

TERMS OF AGREEMENT

Below are conditions under which permission is granted to reproduce works of art in the collection of the Sheldon Museum of Art, University of Nebraska-Lincoln.

1. The Sheldon Museum of Art makes no representation that it is the owner of any copyright in the works of art in its collection. The Sheldon can grant the permission requested only to the extent of its ownership of the rights relating to the request. Certain works of art, as well as the photographs of those works of art, may be protected by copyright, trademark or related interests not owned by the Sheldon. The responsibility for ascertaining whether any such rights exist and for obtaining all other necessary permissions remains with the applicant. The applicant agrees to indemnify the Sheldon and hold it harmless against all such claims, including copyright infringement claims, royalty or fee demands, and/or actions, including the costs thereof, arising as a result of the applicant's reproduction of the work(s) of art in its collection.
2. Any and all requests for photography and reproduction must be made in writing.
3. Only upon receipt of payment and signed contract will photography be sent and permission for reproduction be granted.
4. Permission is granted only for usage in one publication, one edition and one language.* Usage in more than one format, medium, print run, or edition must be requested separately, and will be charged an additional reproduction fee.
5. Digital images provided to the borrower by the Sheldon must be electronically deleted after intended use. Under no circumstances will permission be granted for utilization of a digital image downloaded from the Sheldon Museum of Art web site or any other source on the Internet for publication or reproduction. All digital image uses (CD-ROM, website, etc.), whether initially provided in digital or photographic format, must be no more than 72 dpi and must contain encryption or other security features to prevent reproduction or distribution of the image.
6. The reproduction must be accompanied by full documentation and ownership credit, as listed on the reproduction contract. Full documentation consists of artist's name, title of work of art, date, medium, and size, in addition to the full object credit line and any photo credit line.
7. The work of art is to be reproduced without cropping, "bleeding", alteration, or overprinting of any kind. Reproductions may not be printed on color stock. If a detail of the work is shown, the caption must include the word "detail" and a full view must be shown as well.
8. Special permission is required for commercial editorial material if the reproduction is to appear on a dust jacket, book cover, brochure, calendar, or the like, or is to be published as an individual reproduction. A color proof and the final layout must be submitted for approval by the Sheldon Gallery prior to production.
9. The Sheldon Museum of Art is to receive one copy of the publication for addition to its archives.

All Image Resources requests must be made in writing. Upon receipt of payment and signed contract, permission for reproduction is granted by the Sheldon Museum of Art.
